

Correct Method of Ball Mark Repair

RIGHT

- 1) Insert tool on the high side behind the ballmark.
- 2) Push the back of the ball mark toward the center.
- 3) Do not lift or twist with the tool.
- 4) Close the hole by pushing both sides of the mark into the center.
- 5) Gently tap the surface down with your putter.
- 6) Never use a piece of loosened turf for repair.



Only YOU can prevent ball mark damage!



WRONG!

Do not pull up with green repair tool. This will only bring sand to the surface and tear the root system.

Rules

Benefits of Knowing the Rules

I wrote this article 4 years ago. Since this is my last newsletter, I thought it would be a good idea to come full circle and review why playing by the rules is the only way to play the game.

In the beginnings of the game, each club had different rules as to how the game was to be played. In 1744, the Honourable Company of Edinburgh Golfers came up with a set of rules that all clubs could use in competitions between clubs. This ensured that everyone was playing the same game. Since that time the rules have become as much a part of the game as driving and putting. Incidentally, they had 13 rules. How things have changed!

The Rules of Golf, by necessity, are complicated. Other sports have a standard playing field. All football fields are 100 yards long (120 including end zone) and 53 ½ yards wide. Bases are 90 feet apart on all MLB baseball fields. There are no two golf courses that are alike. No other sport has a goal so small in relation to the size of the playing field. This means the rules have to be comprehensive enough to handle all the variables that can arise.

Our members all have different backgrounds. Some have played a lot of competitive golf and are very knowledgeable of the rules. We also have members who may be new to the game or may have played strictly on a recreational level and their first taste of competitive golf is with our association events.

So, what are the benefits of everyone learning more about the rules? I do not believe that anyone intentionally violates the rules. They are violated because of ignorance of the rules, carelessness, or just going "braindead" for a moment in the heat of competition.

Regardless of your level of rules expertise, we can always rely on the two basic principles of Golf Rules:

- Play the ball as it lies
- Play the course as you find it

These two principles will usually keep you out of trouble.

For you golfers with limited knowledge of the rules, you are not alone. Never hesitate to play in Association events because you feel you are lacking in this area. There is usually someone in the group to help with rules situations. And what if you do break a rule? Welcome to the club. The greatest players in the world all have had rules violations. Do not be upset at the player who points out your violation. I assure you no one wants to be known as a "rules cop" or a "nitpicker." We play every week with our friends and neighbors. They usually feel awkward calling a penalty and don't want to win on a technicality. Use this instance as a learning opportunity. You probably won't make that mistake again. In stroke play, a player is obligated to protect the field. In match play, a player can ignore a violation or exercise his right to call a penalty. A good way to avoid these situations is to prevent them before they happen. Increase your knowledge of the rules and you increase your likelihood of avoiding penalties. And remember, knowledge of the rules can often help you. Sometimes the rules can work in your favor.

For you golfers with a good grasp of the rules, here is your chance to be a mentor. While there is no obligation to help an opponent or fellow competitor with rules situations, there is no prohibition in the rules in doing so. Sometimes, depending on the nature of the violation, prevention is unavoidable. If, however, you see someone about to commit a violation (i.e. dropping in a wrong place), you could just let him do that and call a penalty – that is your right. It's just as easy, however, to be a "mensch." You can point out the error and help him correct it before he incurs the penalty. This attitude is certainly more in line with our MPMGA Constitution Article II which states we want to promote "good fellowship."

So how do you learn more about the rules? A good place to start is your Players Edition of the Rulebook, especially definitions (now called the free rules of golf mobile app). The USGA website has numerous videos and articles which illustrate common rules situations. The Association also conducts rules clinics with AGA experts as well as local board members. These clinics are free and are available to everyone. I encourage everyone to contact me if you have rules questions.

Handicap

Gentlemen, there are some changes coming in 2024 in the WHS (World Handicap System). There are three main changes to be aware of.

Below is a quick summary of those changes from the USGA. Number two and three are the ones that will impact our indexes. If you have questions, let us know.

Introduced in January 2020, the World Handicap System was based upon three key principles: Be inclusive, provide a consistent measure of ability, and remain modern. Four years later, with the first revision to the WHS set for this January, those same principles apply to the main changes going into effect, namely:

1) A lower minimum length for a golf course to obtain a Course Rating™ and Slope Rating™

Under the current system, an 18-hole course must be at least 3,000 yards to receive a Course Rating and Slope Rating (or 1,500 yards for 9 holes). Starting in 2024, the yardage requirements will be cut in half, to 1,500 and 750 yards, respectively. This is good news for golfers who regularly play par-3 and shorter-length courses and have wanted those scores to count toward their Handicap Index®.

2) A new treatment of 9-hole scores

Today, 9-hole scores are combined in the order posted to create an 18-hole Score Differential™. This means that a 9-hole score shot today could be combined with a 9-hole score from days, weeks, or even months before – which can lead to volatile results. Beginning in 2024, when a player posts a 9-hole score, it will be combined with their expected Score Differential over 9 holes to create an 18-hole Score Differential for immediate use – with expected score based on the player's Handicap Index at the time the round is played as well as a course of standard difficulty.

3) An updated approach for holes not played

At present when a hole isn't played (due to darkness, for example), the score recorded is a net par. When the 2024 revision goes into effect, when 10-17 holes are played, an 18-hole Score Differential will be determined by adding the player's Score Differential from the holes played to an expected Score Differential for the number of holes not played. Since a player's expected score is not specific to a course or reliant upon the course's stroke index allocation (as net par is today), this will lead to more consistency.

We will be sending out more information regarding #3 posting requirements.
